"Another feather to the cap of Jagraon Cops

-HEAVY Recovery of DRUGS."

While addressing the press conference, Sh. Rajbachan Singh Sandhu, PPS, SSP Ludhiana (Rural) stated that for making the District Drug free, Ludhiana (Rural) Police launched a special campaign against drug peddlers, smugglers and anti social elements. During this campaign, under the supervision of Smt. Gurmeet Kaur SP(OP), Ludhiana(R) Additional Charge SP(D) Ldh(R), Sh. Anil Kumar Bhanot, PPS DSP-D LDH-R and Insp. Prem Singh Incharge CIA Jagraon, ASI Sikander Singh, CIA Staff Jagraon alongwith his police party was present at the Bridge village Malak when he received secret information that Joginder Singh son of Surjit Singh resident ward no. 5 Balochan Basti P.S City Ferozepur, deals in smuggling Opium whom is coming towards Jagraon through Bujrag, Cheemna and Malak on his Black Activa and if he is nabbed a huge quantity of Opium may be recovered from him. On this information, case **FIR No. 180 dated 02-12-2021 u/s 18, 25,61, 85 NDPS Act was registered at Police Station Sadar Jagraon** against above said Joginder Singh . During nakabandi ASI Pahara Singh along with police party nabbed Joginder Singh son of Surjit Singh resident ward no. 5 Balochan Basti P.S City Ferozepur along with Activa bearing number PB-05AD-4791. After search of the activa **1 Kg. opium was recovered from under the seat.**

Another case **FIR No. 179 dated 02-12-2021 u/s 15,18,25,61, 85 NDPS Act was registered at Police Station Sadar Jagraon** against Jagroop Singh @ Jupa s/o Bant Singh r/o Rasulpur on secret information received by ASI Randhir Singh that said Jagroop Singh deals in smuggling Opium, who is coming towards his village on his truck through Nanaksar and if he is nabbed a huge quantity of Opium may be recovered from him. During nakabandi SI Chamkaur Singh along with police party nabbed Jagroop Singh @ Jupa s/o Bant Singh r/o Rasulpur along with his truck. After search **500 gm opium and 18 kgs poppy husk were recovered from inside the cabin of the truck bearing number PB-10EC-1091.**

It is worth to mention here that the above said accused Jagroop Singh @ Jupa is involved in two more cases also:

2. FIR No. 263 dated 08.11.2017 U/S 15/61/85 NDPS Act P.S Hathur.
